

The Annual General Meeting of the Suffolk Guild of Ringers Saturday 7th April 2018, St Edmundsbury Cathedral Minutes

85 people came along to the Barn Dance last year and it raised a profit of about £209.00. Ralph Earey gave the report.

18. Any Other Business

- i. Freda Smith Jonathan Williamson reported:- whilst not a long serving member of the Guild, Freda Smith of St. Matthew's Ipswich will turn 100 years old on 27th June this year. I think she was first elected along with the rest of the band we taught there in 1992 though she had been a ringer before that time. She was one of only two volunteers who could already ring when we started at St. Matthew's with over 20 volunteers and her support was invaluable. She is still a member of St. Matthew's and still going strong, though no longer ringing. She is now supporting the revitalized efforts at St. Matthew's to keep the bells going. So well done Freda Smith.
- ii. Annual Report: Julian Colman asked if we needed a hard copy of the Annual

Report or Newsletter given that many reports are all online. He said that the Guild could save money for the Restoration Fund.

Richard Knight said that the document was a historical document but that most people were now online.

Sally Munnings asked if it was needed several copies per family. She said the Peterborough Guild purchased a report for their own tower or personal use.

It was noted that the newsletter was the Guild Magazine and was a document for places beyond the Guild members. Shirley Girt said that the magazine was great for those no longer able to ring and was a link from one generation to another.

Katherine Salter said that the amount of money we would save was negliable when thinking about PR and front of house productions.

Jed Flatters asked if we could have a show of hands to get a general feeling of who wanted what. A straw poll was taken. Nearly 80% of those present felt it necessary to keep a hard copy.

iii. Armistice Ringing: Jonathan Williamson asked the meeting to consider Guild activities about this event.

Tom Scase, Ringing Master, wanted us to ring at as many towers as possible on 11th November.

Neal Dodge had requested that tower names were sent to him ASAP for PR. John Girt said that Suffolk was very bad at registering towers.

The chairman encouraged everyone to be active.

- **iv. Veterans Day:** Jenny Scase said that this was on Wed 11th July, 2pm at Debenham.
- **v. Safeguarding:** Mary Garner said that information was sent round to everyone on the Guild lists, and this information was produced in line with the Diocese of St Edmundsbury and Ipswich policy.

The policy holds true and that training should be completed.

Brian Whiting asked how the system was monitored. MG said that PSO of each parish should keep a list of relevant documents and details.

vi. CCCR: David Stanford asked what views the CCCR reps would be taking to the next meeting. The chairman stated that the reps were not directed by the GMC but where important votes were concerned the GMC might state their position as had been the case with the CRAG report. Veronica Downing said that the changes at CCCR are going ahead as of votes made last year.

19. Date of the next AGM: Saturday 27th April, 2019, in the SE District

Simon Rudd, chairman of the Mancroft Appeal 300 project, was welcomed to speak following the meeting. He spoke about the facilities available and provided a number of leaflets.
