13. Amendments to the Constitution and Rules.

The GMC had proposed the following changes

The following changes to take effect immediately:

Constitution

Clause 5 to be deleted and replaced with:

5. There shall be four Districts, North East, North West, South East and South West. Towers may move from one District to another with the agreement of both Districts and subject to approval by the Guild Management Committee (GMC).

Clause 7 to be amended by replacing "Guild Management Committee (GMC)" with "GMC"

Clause 26.1 to be deleted and replaced with:

Fourteen days' notice of any proposed change to the Constitution and Rules of the Guild must have been provided to members through the Ringing World and the Guild website.

Guild Rules

Rule 3 to be amended by the insertion of "after their nomination has been approved by the GMC" after "at a Guild AGM".

Rule 9 to be deleted and replaced with:

9. The Guild Management Committee (GMC) shall consist of the Guild Chairman, Ringing Master, Secretary, Treasurer and Chairman of the Belfry Advisory Committee, and up to five members from each District, elected in accordance with Rule 20.

Rule 10 to be amended by replacing "representatives" with "members"

Rule 22 to be amended by replacing the word "Newsletter" with "Magazine" on both occasions.

The following changes to take effect for each District from the next Annual District Meeting:

Rule 20 to be deleted and replaced with:

20. The following Officers shall be elected annually: Chairman, Ringing Master, Secretary/Treasurer,

Magazine Correspondent, two members to serve on the RTC and up to five members to serve on the GMC.

20.1 A District may elect additional Officers as required to assist in the running of the

District.

20.2 The District Officers shall form the District Committee, which shall be responsible for

the efficient management of the District's affairs and shall report to the Annual District

Meeting on the year's work.

Trevor Hughes raised an objection. Graham Downing would like the wording to be clearer and approval of GMC must be clarified. PJG reinforced that GMC would always oversee proposed changes and are not likely to approve unworkable changes.

John Girt stood to explain the reason for the current organisation. There used to be 5 districts and it was proposed that each district should have the same number of deaneries (C.1972) These were set out to divide the Guild into equal parts for representation of members on GMC.

PJG explained the reason for the changes to the rules to cover future events such as collapse of RW etc.

He also explained the reason for change to Election of LHM This was to ensure that inappropriate proposals for LHM could no longer be made, although a GMC refusal could always be overturned by the members at an AGM.

GMC Deanery Representation. The idea behind this was that each district may elect up to 5 members to sit on the GMC. It is hoped that the new system will encourage members who are interested in being part of the GMC to opt into being elected. Trevor Hughes said that he thought it was important that people interested in moving the Guild on should be taking part on the GMC.

PJG went on to further explain the reasons for changes to the rules. Essentially the districts should elect to the GMC those people that they feel would best serve the Guild.

Changes to Constitutions - Majority in favour one abstention

Changes to Rules - Overwhelming Majority 3 abstentions.

14. Election of LHM.

Maggie Ross explained that Helen Price of Southwold and Reydon has been a loyal and hard-working member of the NE District. She has taught many to ring, she undertook the new installation fundraising for Reydon. A member since 1979, she is always happy to try new things and goes the extra mile to encourage others. She has been district RM, and she has had a hand in all events including tower maintenance. She leads by example well worth following.

Helen Price stood to thank you to the meeting and to everyone who has supported her. She was unanimously elected as LHM.

15. ITTS

3 courses have been held in the county, two at level 1 which have progressed 15 new ringers, and 5 into membership of the Guild. There is a level 1 course being started at Mildenhall, and one in the SE District in conjunction with the Essex Association.

16. Mini Ring

The Vestey ring continues to appear at events both within and outside the county and promotes good publicity for the Guild.

- 17. Both the Guild Dinner at Woolpit and the barn dance at and Sproughton were very successful.
- **18.** George Salter is leading a band to take part in the Young Ringers Striking competition being held at York.
- **19**. A memorial weekend is being arranged to commemorate the life of Rod Pipe, a former Suffolk Ringer and brother to George Pipe. All Suffolk Guild members are invited and details will follow It is the weekend of 12th October
- 20. There were no matters arising from the minutes of the 2012 AGM
- **21.** St Edmunds Clapper Competition was won yet again by Offton with a splendid effort in raising £385 for the BRF.
- **22.** The 2014 AGM will take place on 26th April 2014 in Stowmarket at the invitation of the NW District.

23. Any other Business

On the 12th October ringing has been arranged in several towers in Ipswich and the NE District is organising a walking tour in Ipswich on that day so collaboration will be required.

A card is being circulated to send to George Pipe who is in Papworth awaiting heart surgery on Monday.

Mr Girt asked for a collection for the BRF from the meeting.£118.31 was raised and a further surplus of tea donations of £60.25 was also given to the BRF.

Brian Whiting asked if members were able to put names to all 140 members in the 1974 photo at BSE in the Ringing World as part of Harold Egglestone's obituary.

Chris Garner asked for email addresses from any members wishing to receive information.
